Nature and details of the action(s) taken or order(s) passed	The Agencia de Recaudacion de Control Aduanero tax authority has imposed a penalty on Motherson SAS Automotive Modules and Services Argentina S.A. ("MSAS Argentina"), an indirect wholly owned subsidiary of Samvardhana Motherson International Limited ("the Company"). The penalty was imposed on MSAS Argentina as it inadvertently claimed tax credits or deductions (VAT input, or expenses) during the year from 2019 to 2023 against invoices received from supplier that were found to be noncompliant with the regulations of ARCA. The above penalty pertains to a period prior to the acquisition by the Company, during which the business was under previous ownership. The Company completed the acquisition of SAS Autosystemtechnik GmbH Germany on July 31, 2023.

Details of the violation(s) / contravention(s) committed or alleged to be committed	ARCA has imposed a penalty on MSAS Argentina amounting ARS 56,436,886.20 (Fifty-six million, four hundred thirty-six thousand, eight hundred eighty-six Argentine pesos and twenty centavos only) equivalent to INR 3,665,406/-(approx.) (Three million six hundred sixty-five thousand four hundred six rupees only).

MSAS Argentina proposes to take the matter with seller under Indemnity provision which will be subject to limitation period.
