**Subject: Acquisition Update - Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulation, 2015**

Dear Sir / Madam,

This is with reference to letter dated July 24, 2023, regarding acquisition by Samvardhana MotherSON Automotive Systems Group B.V. ("**SMRP BV**"), a wholly owned material subsidiary of the Company, through SMRPBV's subsidiaries and other group entities.

As mentioned in aforesaid disclosure dated July 24, 2023, SMRP BV had decided to acquire identified assets and certain employee liabilities of the German entities of Dr. Schneider Holding GmbH; 100% shares in the foreign subsidiaries of Dr. Schneider group in Spain, China, USA and Poland and 21% shares in Symbiose SAS (together referred as "Dr Schneider Group"). Dr. Schneider Group is a manufacturer of innovative, high-end interior components with global technology offerings, who filed for insolvency in September, 2022.

Upon completion of regulatory process / conditions precedent, SMRP BV has now completed aforesaid acquisition on October 2, 2023 ("Closing Date"), of the entire transaction perimeter except 21% shares in Symbiose SAS. The acquisition of this minority shareholding in Symbiose SAS has no material implication for the business and will be formalized and completed post Closing Date for an amount not more than 50k Euros.
