In relation to the resolution proposed to the shareholders at the forthcoming 34th Annual General Meeting of Motherson Sumi Systems scheduled to be held on 17th of September 2021, for re-appointment of Mr. Takeshi Fujimi, nominee of Sumitomo Wiring Systems Limited, as Director and his low attendance during financial year 2020-2021, the Company hereby submits and clarify as under:

“Sumitomo Wiring Systems Limited (SWS), one of the promoter shareholders has two Nominee directors on the Board of the Company viz. Mr. Shunichiro Nishimura and Mr. Takeshi Fujimi. Whereas Mr. Nishimura has attended all the Board meetings held during the year (2020-21); Mr. Fujimi had some conflicts in the prefixed schedule (Mr. Fujimi looks after quality assurance function for Wiring Harness at SWS).
